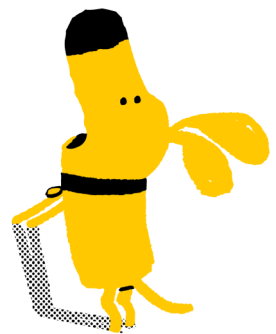
What will it cover & who is it for?



Dogs Trust USA, the affiliate charity of the UK's largest canine welfare charity—Dogs Trust, is offering a free, 2 day seminar that has been designed to support rescue and shelter staff and volunteers by providing a strong foundation of knowledge in canine behavior. The first day will be looking at all things related to welfare and how we can best support the dogs through their journey in our shelters. We will start by looking at how to interpret body language and then explore the fascinating world of enrichment.

In the afternoon we will be looking at how we can approach veterinary care with a holistic welfare approach and consider what safety precautions and training we can implement to ease this experience.

The second day will be focused on how we can better support dogs by working with them to set them up for success. We will examine the fundamentals of learning theory, while looking at the practical applications of positive reinforcement with basic training to support rehoming, as well as troubleshooting what we can do to improve the effectiveness of training and breaking down why unwanted behaviors develop.
