Foster-to-Adopt Agreement

Live Love Animal Rescue's foster-to-adopt agreement is set for specific dogs that have medical and/or behavioral needs that require an extended time to address and where a family has expressed an interested in adopting the dog at the appropriate time. This agreement outlines this relationship where the interested family functions as a foster family until the medical and behavior needs are met for the dog and at the appropriate time, as determined by the Live Love Board, will be adopted by their foster family. The foster term adheres to the standard Live Love foster agreement including terms relating to medical, expenses and integrations with family members and pets. As noted below, adoption by the foster family will not be finalized until the Adoption Contract is signed and adoption fee paid.

Foster Home Guidelines, Responsibilities, and Release of Liability

Please read each item and check the box if you agree. All boxes must be checked to successfully complete the form.

I agree to the following GENERAL AGREEMENTS regarding my foster pet: *

- I understand that the ID tag provided by Live Love Animal Rescue must be worn by the foster pet at all times. I agree to contact Live Love Animal Rescue immediately if this tag is damaged or lost, in order to obtain a replacement.
- I understand and agree that I am responsible for the safety of the foster pet and other pets and people the foster pet comes in contact with.
- I agree to keep my foster pet safely confined in a fenced yard, kennel run, or inside a house or garage when the dog is not with me or a member of my family. Live Love Animal Rescue recommends the use of an indoor crate for safe confinement and can provide assistance with crate training if needed.
- I agree to keep my foster pet on a leash when outside my home or securely fenced yard.
- I agree that at no time will my foster pet be placed outside on a tie-out in a yard, outside a store, etc.
- I understand and agree that my foster pet will NOT be allowed to run or play off-leash in a dog park or any other open public area. Off-leash permission may be granted on a case-by-case basis, but I agree to obtain written permission from Live Love Animal Rescue before engaging the foster pet in these activities.
- I agree to immediately notify Live Love Animal Rescue if my foster pet is injured or lost by calling/texting 213-282-PAWS or sending an URGENT email to woof@liveloveanimalrescue.org.
- I understand that all foster pets must be spayed/ neutered and vaccinated. If I am fostering an unaltered dog, Live Love Animal Rescue may request my assistance in transporting the foster pet to/ from a Live Love Animal Rescue-approved vet for these procedures. If I am unable to provide or arrange transportation, I will notify Live Love Animal Rescue and assist in any way I can.
- I understand that if I need to return the foster pet for any reason, I must immediately notify Live Love Animal Rescue. I agree to keep the foster pet for at least 72 hours following the initial notification while Live Love Animal Rescue locates a new foster home placement for the foster pet.

I agree to the following regarding EXPENSES covered by Live Love Animal Rescue: *

- I understand that all basic medical expenses for the foster pet will be covered by Live Love Animal Rescue, provided that Live Love Animal Rescue has approved the medical expenses and the care is provided by a Live Love Animal Rescue-approved veterinarian.
- I understand that covered medical expenses are limited to medically necessary procedures as determined by the Live Love Board of Directors and partner veterinarians.
- I understand that if I choose to take the foster pet to a vet of my own choosing, that I may be responsible for the medical expenses.

- I understand that Live Love Animal Rescue will cover training costs if the foster pet is determined by the Live Love Board of Directors to require more extensive training than I am able to provide. I agree to provide basic obedience training, and to contact Live Love Animal Rescue if I need training assistance.
- I understand that Live Love Animal Rescue will provide a collar, ID tag, leash, and an initial supply of food for the foster pet. Live Love Animal Rescue will provide other donated items, such as a bed or blankets, as they are available. Crates can be lent to foster homes but must be returned upon adoption of the foster pet, or additional payment added to the adoption fee.

I agree to the following regarding INTEGRATING my foster pet with my family: *

- I agree to never leave a child unattended with a foster pet.
- I agree to never leave bones or treats around the house when children are present, and to be cautious and observant when children are eating in the presence of the foster pet.
- I agree to have the foster dog eat and sleep in its crate or in a separate room if there is a child under the age of 5 in the foster home.
- I agree that children under the age of 13 will not walk the foster pet unless supervised by an adult.
- I understand that whenever there is a child in the house with a foster pet, there is a risk of being accidentally knocked down, scratched, bitten, etc.
- I agree to contact Live Love Animal Rescue immediately if I have any concerns or feel uncomfortable about a situation between a foster pet and a child. Live Love Animal Rescue will either remove the dog from the foster home, or arrange for a trainer to meet with the foster family, depending on the severity of the situation.

I agree to the following regarding INTEGRATING my foster pet with my current pet(s): *

- I understand that Live Love Animal Rescue cannot guarantee the behavior of the foster pet with pets in the foster home, even if the foster pet has been housed with pets previously.
- I agree to use caution when introducing the foster pet to existing cats in the household. I agree to do the introduction slowly, over a period of a few weeks, keeping the foster pet on leash. Live Love Animal Rescue will assist with this process if needed.
- I agree to use caution when introducing the foster pet to existing dogs in the household. Live Love Animal Rescue will assist with this process if needed, or will arrange for a trainer to assist with this process.
- I agree that I will never leave multiple dogs at home in the same room unattended.
- I agree to feed the dogs in separate rooms to avoid food aggression.
- I agree to monitor the use of toys and treats at all times, and put them away when I am unable to monitor.

I agree to the following regarding the ADOPTION of my foster pet: *

- I understand that fostering-to-adopt a pet is NOT the same as adopting a pet, and that I do not have full control over care decisions for the foster pet until the adoption is finalized by paying the Adoption Fee and filling out the Adoption Contract.
- I understand that the foster pet's adoption may not be finalized before the pet is spayed/ neutered, and the pet's medical, behavioral, or other concerns are considered rehabilitated/ adoptable by the Live Love Board of Directors and partner veterinarians and trainers.
