Dr. Jeffrey Young, Founder, Planned Pethood International, Animal Planet’s *Rocky Mountain Vet!*

It is never too late to correct our course!

The number one cause of death for cats and dogs in the developed world is euthanasia. Between 1990 and 2010, there was an 80% drop in shelter euthanasia. Yet since then, progress has slowed and reversed as we have been distracted to think we can rescue, warehouse, and adopt our way out of pet overpopulation. To become a part of the honest solution, which is not rocket science, we must return the focus of companion animal welfare to the prevention of litters and education (in schools, behavioral counseling and training classes to the public).

As of now, we have failed to follow through on what we know to be the solution. However, it is not too late to correct the course that we as a country—and a movement—have taken. Support and give to make a real difference. And remember, while brick-and-mortar looks great, it does nothing to solve the problems we have. Also, remember that simply being alive does not imply quality of existence. We know the solution; our task is to break down the barriers and just get the job done. We can do it.

About Dr. Jeffrey Young

Dr. Young graduated from Colorado State University School of Veterinary Medicine in 1989. He established Planned Pethood Plus, Inc. (PPP) in 1990. PPP is best known for its low-cost mobile neutering services, Native American reservation work, and training of veterinarians from around the world in more efficient surgical techniques. Dr. Young has served on or consulted with numerous humane society boards nationally and internationally. He has founded his own non-profit group called Planned Pethood International (PPI). PPI was established to help fund spay/neuter work and veterinary training involving numerous veterinary hospitals and veterinary schools around the world. PPI has a well established International Training Center (ITC) in Playa del Carmen, Mexico, offering free training for qualified candidates and having had hundreds of veterinarians and veterinary students come for hands-on training. There is also a new training center in Conifer, Colorado.

Dr. Young is most proud of having personally sterilized over 185,000 animals in the last 32 years, and he is an outspoken proponent of early age neutering for companion animal population control. Dr. Young has the number one ranked TV show on Animal Planet, “Dr. Jeff: Rocky Mountain Vet”. He has used this platform to promote population control and basic medical needs for all companion animals. Dr. Young is driven by a simple underlying mission, “to significantly reduce companion animal overpopulation and suffering throughout the world.” His motto, “Think Globally Act Locally.”

Affordable and Accessible Spay/Neuter Programs Through the Use of Mobile Veterinary Clinics

This will include planning, budgeting, and training to provide an efficient and effective program while still providing high-quality care. The presentation will also briefly discuss how we can use this program to train and involve other veterinarians and veterinary students interested in HQHVSNS.

About A Michelle Gonzalez, DVM

Dr. Gonzalez was born and raised in Puerto Rico. Obtained a BS in Zoology from Michigan St University, DVM from The Ohio State University, and completed an Internship in Small Animal Medicine, Surgery, and Critical Care at the University of Missouri. Dr. Gonzalez founded the Rascal Unit in 2006, a mobile veterinary clinic aimed at providing affordable and accessible care to underserved areas in Ohio. In addition to HQHVSNS, Dr. Gonzalez has a MS in Veterinary Forensics from the University of Florida and a MS in Forensic Psychology from Southern New Hampshire University and works with local and national humane organizations in animal welfare initiatives and cruelty and neglect investigations.

Do You Need More Spay/Neuter Capacity? You Can Do It!

Are you constantly struggling to find time in private clinics' schedules to alter one or two community cats a week? Are you challenged by the seemingly limited number of veterinarian resources in your community? The presentation describes how one group tackled this problem in a way that not only solved it for the moment but set the groundwork for moving the entire community forward toward embracing TNR for the long haul. In this presentation, out of the box thinking will be shared that helped build a successful, life-changing program in Kentucky with the goal of helping you develop a program that will work perfectly for your community.

About Karen Little

Karen and her husband founded the nonprofit Trap-Neuter-Return (TNR) group Alley Cat Advocates in 1999. Based in Louisville, Kentucky, the group has altered over 60,000 community cats and has worked to transform the culture of care provided community cats in the region. The group altered their first 24,000 cats using a mash style spay/neuter clinic in a transformed janitorial warehouse. In 2012, Karen was instrumental in helping pass an ordinance change that propelled the implementation of an extremely successful municipal Return-to-Field program, moving the city's Save Rate for cats to over 95% where it has remained for the past 5 years. Since 2018, Alley Cat Advocates has held the citywide contract for Trap-Neuter-Return and all related community cat issues. In 2020, under Karen's direction, a successful capital campaign concluded with the opening of a Community Cat Complex dedicated solely to the care and well-being of community cats. The complex houses a high quality, high volume spay/neuter clinic as well as medical space for housing and caring for community cats needing extra care.

About Dr. Katie Todd

Dr. Katie Todd is a 2012 graduate of the University of Pennsylvania. She has been a volunteer with Alley Cat Advocates for over 15 years, first as a technician, then as a volunteer surgeon and board member. She is now serving in the role of Lead Veterinarian for the organization. She also volunteers with the HSUS Rural Area Veterinary Services (RAVS) program and Louisville's Pets4Life, both focused on providing access to veterinary care for underserved populations. Dr. Todd provides relief veterinary services across the U.S., both in HGHVSN surgery as well as general practice and emergency medicine

Dr. Becky Morrow is a shelter veterinarian and professor who is very active in the animal rescue community. She founded Frankie's Friends Cat Rescue in 2010 after she cared for over 400 cats rescued from Tiger Ranch, a massive institutional hoarding facility. She has performed tens of thousands of spays and neuters and teaches High Quality High Volume spay/neuter techniques to other veterinarians and veterinary students. Dr. Morrow is often called upon to speak on topics related to community cats and TNR and has worked with dozens of shelters and rescues in Western Pennsylvania to bring the mobile surgical unit to underserved regions. In addition to being President and Medical Director at Frankie's Friends, Dr. Morrow is an Assistant Teaching Professor at Penn State University and an Adjunct Assistant Professor at the University of Florida College of Veterinary Medicine's Online Shelter Medicine Program.

While USA is working to update and maintain a list of low-cost spay/neuter services, our state leaders help answer questions and make referrals that only a local could know. Hear more about what it's like to be a state leader with USA, and what these folks are doing to lead the charge for spay/neuter in their home states.

About Vicki Deisner

Vicki is the Executive Director of Ohio Animal Advocates (OAA), and a founding member of the Coalition of State Animal Advocacy Organizations. OAA is United Spay Alliance's (USA) Ohio partner, hosting the Ohio S/N Connection that provides statewide resource lists including low-cost S/N, TNR, pet food pantries and where to report cruelty. OAA's community cat programs include annual statewide and regional community cat summits, where last year, along with our partner Together Initiative for Ohio's Community Cats, introduced the first statewide comprehensive list S/N and TNR resources and the report on Ohio's TNR deserts.

Vicki is also currently the State Government Affairs Advisor for the Animal Welfare Institute, and was formerly the Midwest Legislative Director of the ASPCA, where she was responsible for legislative and advocacy initiatives in the states of Ohio, Michigan, Indiana, Illinois and Kentucky. Prior to that she served as the Associate Director of the National Water Resources Campaigns for the National Wildlife Federation in Washington, DC, Executive Director of the Ohio Environmental Council and Ohio Assistant Attorney General, Environmental Enforcement Section in Columbus, Ohio.

Vicki received her J.D. from Salmon P. Chase Law School at Northern Kentucky University, her clinical degree in Respiratory Therapy from the University of Chicago, her M.S in Physiology from the University of Cincinnati, Medical College, and her B.S. in Zoology from The Ohio State University.

About Liz Rudder

Liz is the President of Operation SPOT (Stop Pet Overpopulation Today) in St Louis, Missouri. In 1995 in the St. Louis area, too many healthy dogs and cats were being euthanized in area pounds and shelters. Representatives from almost all of the animal welfare organizations and municipalities joined together to address the problem and look for answers to what everyone was experiencing, killing healthy animals simply because there was no room in the shelters. Liz was one of the charter members of this task force.

The answer to the pet overpopulation crisis needed to be a 3-part approach: public education about responsible pet ownership, legislative efforts to help the shelters and animal controls safeguard the dogs and cats, and an area wide program to provide affordable and accessible spay/neuters.

OpSPOT was formed as a 501c3 organization and went straight to work. Liz was elected as the first president and tasked with providing those spay/neuter services. In the beginning, OpSPOT worked with local vet clinics, reimbursing them for spay/neuter procedures. From there, they acquired a used transport vehicle and developed programs to transport pets to local vet clinics. Then, the donation of a SWBell

mobile office allowed OpSPOT to outfit a mobile spay/neuter clinic which continued to work in targeted communities, both rural and inner city. Today, OpSPOT has delivered over 53,000 procedures.

About Cheri Storms

Cheri is the Executive Director of Pet Friendly Services of Indiana. She made the jump from environmental policy work to animal welfare, joining the board of Pet Friendly Services of Indiana in 2005 to help grow the grassroots organization. Within five years, Pet Friendly Services obtained a specialty license plate, providing the organization with the needed revenue stream to fund spay/neuter surgeries across Indiana. Pet Friendly Services now has a network of 125 vets and provides financial assistance to shelters and rescue groups, as well as to limited-income pet owners.

Due to the need to stabilize outdoor cat populations, and decrease shelter intake, Cheri launched the Community Cat Program to financially support organizations that trap-neuter-return (TNR) feral and free-roaming cats. As a result, Indiana increased the number of TNR programs from 25 to more than 150.

The paperwork involved in running a statewide financial assistance organization was ever mounting. Cheri's team responded by fully automating their processes, allowing Pet Friendly Services to run more efficiently and expedite the spay/neuter certificate process. Automation also included vet reimbursement, allowing participating vets to easily invoice Pet Friendly Services for their work.

Crossing State Lines: Veterinarian License Portability to Increase Spay/Neuter Capacity

On July 1, 2023, a new Florida law went into effect that will broaden access to spay/neuter in the Sunshine State during the ongoing veterinary workforce shortage and beyond. The new law exempts veterinarians who are licensed and in good standing in another state from Florida state licensure, provided they are performing sterilization and preventative wellness services at the time of sterilization as an unpaid volunteer and working under the responsible supervision of a Florida-licensed veterinarian.

How will the new law work? What is the potential for similar legislation in other states? This presentation by the United Spay Alliance Veterinary Shortage Task Force and the ASPCA will discuss Florida's new law, how the coalition worked with state lawmakers to pass the legislation, and how similar legislation can maximize spay/neuter capacity-building impact in other states.

About Jen Hobgood, PhD

Jen is Senior Director of State Legislation for ASPCA's Government Relations Southern Division. She is based in Tallahassee, Florida and oversees the ASPCA's legislative initiatives in Florida, Georgia, South Carolina, and North Carolina.

About Dr. G. Robert Weedon

Dr. Weedon is currently a High Quality, High Volume Spay-Neuter (HQHVSN) Surgeon with the Humane Society of Polk County, in Winter Haven, FL, after retiring as a Clinical Assistant Professor and Service Head of Shelter Medicine at the University of Illinois College of Veterinary Medicine, where he trained veterinary students in HQHVSN techniques.

As an advocate for solving the problem of pet overpopulation, particularly that of community cats, Dr. Weedon volunteered with Friends of Felines, a group that surgically sterilizes feral cats in the Wilmington community and was a volunteer surgeon at the onsite spay/neuter facility at New Hanover County Animal Control Services, where animals were surgically sterilized prior to adoption. Dr. Weedon serves on the Board of Directors of the Alliance for Contraception in Cats & Dogs, an international organization whose goal is to develop and implement non-surgical sterilants to help solve the problem of pet overpopulation worldwide, and was elected Vice-Chairman for 2010, 2011 and 2012. He has been trained in the administration of Esterilsol and Zeuterin, a chemical sterilant for male dogs, and served as a master trainer for its use. Since December 2022, Dr. Weedon has been a member of the Vet Shortage Task Force convened by the United Spay Alliance, and is a volunteer Scientific Advisor for Alley Cat Allies, a global advocate for the humane treatment of all cats.

Dr. Weedon served as the veterinarian on the New Hanover County (NC) Board of Health for six years, and was a member of the Animal Control Services Advisory Committee. At the December 2008 meeting, he was elected Chairman of the Board of Health by his peers to serve in that capacity during 2009. Dr. Weedon served on the Board of Directors of the Public Health Foundation of New Hanover County, having been elected President for 2009, and UNC Public Health Foundation Board. In June 2008, he received the Bill Lehman Memorial Award from the National Animal Control Association as the outstanding animal control volunteer in the United States. After retiring from clinical practice, and prior to assuming the faculty position at the University of Illinois, Dr. Weedon accepted the role of Veterinary Outreach Coordinator with the Global Alliance for Rabies Control in 2009, and prior to that, he was a volunteer ambassador with GARC, giving lectures on rabies prevention. Dr. Weedon is the coauthor of the chapter on rabies in the textbook, *Infectious Disease Management in Animal Shelters*, 2nd Edition, as well as coauthor of two chapters in the recently published textbook, *High-Quality, High-Volume Spay and Neuter and Other Shelter Surgeries*.

Dr. Weedon attended Purdue University where he received his Bachelor of Science in Animal Science and his Doctor of Veterinary Medicine degrees. He received his Master of Public Health from the University of North Carolina Chapel Hill.
