ABOUT THE DEPARTMENT


County of Los Angeles Department of Animal Care and Control (DACCC) serves unincorporated Los Angeles County and 45 contract cities

Operates seven animal care centers located throughout Los Angeles County

Serves more than three million residents and about 25,000 animals annually

Some of the services we provide:


- Animal care and sheltering

- Animal neglect and abuse investigations
- Pet and business licensing
- Community outreach and education
- Barking/noise abatement

MANAGED INTAKE

Implemented in March 2020 during the onset of the COVID-19 pandemic

Community Engagement – Gives the community opportunities to foster, network with animals, and facilitate adoptions

Pet Retention– Provide resources such as food, training, medical care, and supplies to support pet ownership

Stray Animals – Encourage residents to allow free-roaming cats to remain where they live, as well as pet reunification strategies for found dogs

Public Safety and Animal Welfare – Sick or injured animals, or those deemed to pose a safety threat, are impounded by DAC

Got Kittens? Campaign

LOVE AT FIRST SIGHT

Enhanced adoption program implemented in August 2021

Allows for self-scheduling appointments and first-come, first-served adoptions

Addition of “Ready to Go Home” status for animals ready to be adopted now

Great improvements regarding customer service and streamlined process

Adoptions increased by 21% in Aug - Dec 2021 compared to Aug - Dec 2020

Medical HelpLine

- ❖ a counseling and assistance call center to help constituents with pet-related problems and connecting them with resources.
- ❖ Registered Veterinary Technicians and trained Animal Control Officers
- ❖ the program was initially created to provide support to constituents during the Covid pandemic but was sustained because of the overwhelming response from the community seeking guidance on pet care and animal services.
- ❖ Numbers of Calls
 - 2020 : 128
 - 2021 : 1477
 - 2022 : 405

- ❖ Triage cases for ACF Care Voucher







Spay/Neuter Voucher Program (SNVP)

Revised existing SNVP


- ❖ Removed requirements for proof of low income and senior citizen status
- ❖ Only require proof of residency to qualify
- ❖ Included accommodations for the homeless

Total No of Vouchers issued in 2021 : 697



May 2021 : ACCs became Veterinary Providers for SNVP

Vet@ThePark


- A mobile veterinary unit that stages pop-up service areas at County parks to provide free medical wellness service for pets
- Services include medical examinations, vaccinations, deworming, flea/tick treatment and microchip placement.
- Launched in June 2021




In December 2021, DACC signed an MOU with the Department of Parks and Recreation to help constituents gain access to services


Pet Food Pantry







THE IMPACT OF MANAGED INTAKE


Cat/Dog Live Release Rate increased by 14% from 2019 to 2021.




Nearly 20% return-to-owner (RTO) rate achieved in 2021.
