

Foster Care Agreement

(If a Safekeep Foster Provider, do not complete this top portion. Complete bottom section only.)

Thank you for your willingness to the support the animals in need of foster. Foster care providers provide care for all animals that are fostered with them and return them to LHS when requested to do so. Foster care providers agree to the following guidelines:

- 1. Animals in foster care are, at all times, owned by LHS. If LHS staff determines that a foster animal is beyond treatment, the animal may be humanely euthanized. When the foster period is complete, or upon request by LHS, the Foster Care Provider will return the animal(s) to LHS.
- 2. Foster Care providers provide proper food and medical care under the direction of LHS staff, and a caring, safe environment for the foster animal(s).
- 3. Foster Care providers understand and agree to adhere to all relevant zoning and animal control codes and ordinances, whether local, county, or state.
- 4. The responsibility for the foster animal belongs jointly to LHS and the Foster Care provider. However, if for any reason, the foster relationship is not successful, LHS must be contacted for return of the animal. The Foster Care provider will not place the animal in a new home. The Foster

Care provider shall not transfer the animal to anyone other than LHS.

- 5. Foster Care providers will maintain the foster animals' vaccination series and health appointments as requested and/or scheduled by LHS staff. If a foster animal becomes ill, foster care providers will notify LHS immediately.
- 6. All necessary medical care for foster animals will be provided by LHS unless otherwise arranged by the Foster Department. Foster Care providers are discouraged from seeking additional medical care for their foster animals; however, any medical care sought elsewhere, and the costs incurred, shall be the responsibility of the foster care provider. Additionally, no medical care for the Foster Care provider's resident or visiting animal(s) will be provided by LHS in the event that such animal(s) become injured or ill due to exposure to the foster animals whether at the time of foster or thereafter.
- 7. Foster care staff may evaluate prospective foster homes at mutually agreed upon times. Initial visitation and evaluations will not occur without an appointment. Once an animal is placed into the foster home, the foster family agrees to allow LHS to inspect the premises where the animal is kept at any reasonable hour, without prior notice.
- 8. LHS makes no representations or warranties regarding the temperament or physical condition of any foster animal.
- 9. No one can predict how any animal will react in a given situation. If behavioral challenges are evident in the home, the foster care provider will notify LHS foster care staff immediately.
- 10. Dogs will be kept as indoor/outdoor dogs in close companionship with their foster families. Dogs should not be kept outside in extreme temperatures. Dogs will not be on a tether at any time. Dogs will not be carried uncrated in the bed of a pick-up truck. Dogs will not be taken to any dog park or permitted off leash in an unenclosed outside area.
- 11. Cats will be kept indoors at all times.
- 12. LHS shall not be responsible for any bodily injuries or property damage caused by any foster animals or by the actions of its foster care provider. The LHS foster care provider hereby specifically assumes sole responsibility for, and agrees to hold LHS harmless from any and all loss and expenses (including legal fees) by reason of liability imposed by law upon LHS, or any of its officers and members because of bodily injuries or death to any person or persons including the foster care provider, or any damage to property arising out of or in consequence of the placement of the animal, howsoever such injuries, death or damage to property may be caused, whether or not the same may have been caused, or may be alleged to have been accused, by negligence of the aforementioned parties or any of their employees, agents or members, or any other person.
